Background

CAC 45 was convened from 21-25 November 2022 in Rome – Resumption of Physical Codex meetings

Strong Representation from the Arab Region, both Virtual Representation and Physical Participation



Key Outputs of the Session

CCEXEC Report:

- ☐ Resumption of examining requests from new Observers
- ☐ Guidance on the application of the Statement of Principles: Continued discussions and possible pilots
 - Need for further clarification between: Abstention from acceptance and reservation
- ☐ Report on New Food Sources and Production Systems:
 - Important considerations related to the role of standards in supporting innovation and addressing food shortages /emerging issues
 - No agreement to have an EWG reporting to Commission on the subject –
 rather a circular letter to identify priority areas of action
 - The Discussion highlight importance of Inter-Committee Collaboration at Codex
- □CCEXEC Sub-Committee on Future of Codex:
 - Future considerations for amendment of Procedural Manual to account for changes in the way Codex Meetings and work in carried out with the introduction of virtual events





Key Standards Adopted

☐ CCNFSDU:

Guidance on Ready to Use Therapeutic Foods

□ CCFH:

- Guidelines on the management of Biological Foodborne Outbreaks
- Update to General Principles on Food Hygiene (CXG1-1969)


☐ CCFFV:

- Delegations representing date-producing countries objected to the adoption of the proposed draft standard for fresh dates at Steps 5/8 as proposed by CCFFV and considered more technical discussions were needed on the proposed minimum value for moisture content of 30%
- Adopting the standard at Steps 5/8, would exclude some date cultivars and not reflect the reality in the marketplace with negative effects on local production

MAJOR WIN FOR THE ARAB REGION, AS THIS WAS A KEY OBJECTIVE FOR VARIOUS ARAB DELEGATIONS

Highlighted the importance of Coordination between Arab Delegations and Coordination with other Regions / Delegations





Other Key Standards and Discussions

□CCCF:

- Cadmium in Cocoa Standards and Code of Practice
- DON in Cereal-based foods for infants and young children

 Major discussion on the ML for Aflatoxins in several food categories – Reservations from most of Arab delegations

□CCPR:

 Discussions on whether environmental factors should be considered as part of the elements to drive examination of MRLs

□CCRVDF:

- Zilpaterol was adopted as a draft standard at Step 5 through a vote:
 - **87 in favor out of 135** 48 against and 7 abstained
- The move to change the procedure and move to 5/8 adoption did not succeed by 3 votes (84 votes out of 130 needed 87 to pass 2/3 votes)
