#### Items Recommended for Adoption As a Draft Standard at Step 5

□ Proposed Draft Revision to the GSLPF: Provisions relevant to allergen labelling

- $_{\odot}$  This aims to review the existing list of ingredients known to cause hypersensitivity for allergen labelling.
- Two lists were developed based on FAO/WHO Expert Consultation based on prevalence, potency and severity of allergens:
  - $\circ$  Priority list and secondary list (next 2 slides)
    - > Secondary list is recommended to be considered for risk management at the regional or national level.

#### Items Recommended for Adoption As a Draft Standard at Step 5

- Proposed Draft Guidelines on Food Information for Pre-packaged Foods to be Offered via E-commerce
  - This aims to provide guidance on information to be declared on the E-commerce platform where the food is being offered for sale





#### Items Recommended for Adoption As a Draft Standard at Step 5

□ Proposed Draft Guidelines on the Use of technology to Provide Food Information

- This Guidelines aims to provide guidance on the use of technology to provide information about prepackaged foods.
- Name of the food and food information concerning health and safety should not be provided exclusively using technology. This ensures that food safety and personal wellbeing of consumers are not compromised.





# Other Items Discussed by the Committee: New Work

#### New Work

#### □ Approval of new work

- Amendments to the GSLPF (CXS 1-1985): Labelling of pre-packaged foods in joint presentation and multipack formats
  - This standard aims to harmonize the labelling of pre-packaged foods in multipack formats and of foods in joint presentation.
  - This helps to provide the consumer with the information of each of the products that are being acquired, to avoid subjective interpretations and to facilitate communication between the food manufacturer and the consumer.





## Other Items Discussed by the Committee

Review any Other items of Relevance: Revision of the General Standard for the Labelling of Pre-packaged Foods: Guidelines on precautionary allergen labelling

- Precautionary allergen labelling (PAL) is a statement made in the labelling of prepackaged foods to indicate a risk from the unintended presence of an allergen(s) due to cross-contact.
- The decision to use PAL should be based on the findings of a risk assessment which shall include, but is not limited to, quantitative risk assessment
- PAL shall only be used if the presence of a protein from an allergen is equal to or above the action level for this allergen, using the listed reference dose (RfD).

## Other Items Discussed by the Committee

Review any Other items of Relevance: Discussion paper on sustainability labelling claims

- While there was agreement that sustainability is an important topic for Codex, views differed on whether this was the right moment to start new Codex work on sustainability related labelling claims or if further reflection was needed
- Delegations in favour of starting new work felt that high-level guidance could prevent a plethora of unsubstantiated claims, as the General Guidelines on Claims (GGC) does not provide sufficient guidance for substantiation.
- Delegations not in favour of starting new work felt that sustainability is a complex topic that goes beyond the mandate of Codex, other international organizations were already working in this area. Additionally, if work is considered, it should focus on updating and strengthening GGC with a view to cover all types of claims including sustainability-related claims
