DISCUSSION PAPER ON REVIEW OF THE CODE OF PRACTICE FOR THE REDUCTION OF AFLATOXIN B1 IN RAW MATERIALS AND SUPPLEMENTAL FEEDINGSTUFFS FOR MILK-PRODUCING ANIMAL

CCCF13 (2019)

It was agreed to develop an approach for reviewing existing Codex standards developed by the CCCF.

CCCF14 (2021)

It was agreed to establish tracking lists for Codex standards and criteria to prioritize reviews, initiating a three-year trial period for this approach.

CCCF15 (2022)

It was agreed to create an **Overall Highest Priority List** (the "OHPL") of Codex Standards and Related Texts for Contaminants in Food and Feed.

CCCF15 (2022)

It was agreed to develop a discussion paper on the review of the Code of practice for the reduction of aflatoxin B1 in raw materials and supplemental feedingstuffs for milk-producing animals (CXC 45-1997).





### Key Reasons to Urgently Update the Aflatoxin Reduction CoP




Established: 1997

#### **HEALTH CONCERNS**

**Issue**: No Health-Based Guidance Value (HBGV) established

**Reason:** Aflatoxin's genotoxicity and carcinogenicity



Is there new information warranting the revision of CXC 45-1997?


Can the majority of CXC 51-2003 apply to non-cereal feedingstuffs of agricultural origin used as animal feed?

The Arch Codex

The Arab Codex delegations might support this proposal, which will encompass updated information, incorporating recent scientific insights and practices.

The Arab Codex delegations may support the expansion of the CoP's scope to include non-cereal feeds, thereby covering all sources of aflatoxin contamination.

The Arab Codex delegations may emphasize the importance of clarifying definitions and terminology through standardized references to enhance understanding and implementation.
