Launched October 2018

**Goal:** Expand domestic and international trade of food products through supporting the scale-up of the newly established National Food Safety Authority (NFSA) in Egypt.

#### Activities:

- Enhance organizational capacity of NFSA
- Develop workforce training for NFSA
- Promote improved policy & regulatory frameworks

Egyptian National Food Safety Authority (NFSA)



**Established by law in 2017** with Executive Regulations promulgated in 2019.



Empowered to serve as the **sole regulator and inspector of food** in Egypt.



Decisions impact the **trade of food**, both imports and exports, as well as the production and sale of food **domestically.** 

#### Food Inspection in Egypt – Initial Context

### Regulatory

- Legacy of a multi-agency approach
- Outdated and complex technical regulations not based on science
- Reliance on compliance verification vs. preventive controls
- Trade barriers

#### Institutional

- Newly established organization
- Limited human resources
- Reactive vs. proactive
