OPENING REMARKS • Inaugural Ceremony of the Global Food Regulators Summit 2024

20 September 2024, New Delhi, India

Honorable Ministers, Your Excellencies, Distinguished colleagues and participants,

It is a great privilege to represent the food science and technology community as the current President of IUFoST at this 2024 Edition of the Global Food Regulators Summit, hosted by the Food Safety and Standards Authority of India (FSSAI), the Ministry of Health and Welfare and their Partners.

I would like to start by thanking FSSAI and the Government of India for your generous hospitality and for your leadership in convening this forum – A forum that gathers major food regulatory organizations from around the world with such a strong representation from industry, academia and from international organizations is not only needed but indispensable to enable the dialogue, networking, and to shape the strategic directions and priorities for the collaborative agenda addressing food safety, security and sustainability.

As a former regulator, I cannot emphasize enough such importance.

This key driver has led to the creation of the Global Food Regulatory Science Society (GFoRSS), a disciplinary group of IUFoST dedicated to food regulatory science, with the aim to contribute to knowledge generation, dissemination and to building competencies in various food scientific disciplines supporting food regulatory decision-making.

This meeting of the Global Food Regulators Summit will no doubt enable us to discuss avenues of collaboration, of creating networks and coalitions to further contribute to building competencies, capacities and to support the generation and availability of scientific information that underpins such food regulatory decision-making, globally.

Through such enhanced capacities, we would all aim not only to strengthen food control systems nationally, but we also endeavor to enhance our collective contribution to the Codex Alimentarius Commission, the Global Food Standard Setting body, which remains our global reference and anchor, helping us all build a more convergent food regulatory environment, serving the protection of consumers and offering a fair environment for food trade.

Thank you again for your leadership and thank you for giving us such a unique opportunity.
