Introduction

The 7th meeting of the CCSCH was hosted and chaired by the Government of India, in Kochi, Kerala, India (29 January - 2 February 2024)



Dr M.R. Sudharshan is the current chairman of the committee • The fist physical meeting after a gap of five years.

 The physical meeting in Kerala also celebrated the 10th anniversary of the CCSCH, which was established in 2013.

- 30 member countries and one member organization and one observer organization attended the five-day meeting.
- 3 Arab countries (Egypt, Morocco, Saudi Arabia).

CCSCH is mandated to elaborate wordwide, science based quality standards for spices and culinary herbs, in accordance with codex principles of consumer protection and fair-trade practices.

Innovative approach to developing standards by grouping the many spices and culinary herbs into six categories facilitating the development of standards.

11 standards for spices and culinary herbs during its past six session





Three Standards Adopted at Step 8 or 5/8

The Committee agreed to forward to CAC47 for final adoption three texts

Draft standard for spices derived from dried or dehydrated fruits and berries – small cardamom

Draft standard for spices in the form of dried or dehydrated fruits and berries:

Allspice





At Step 8)

Draft standard for dried or dehydrated roots, rhizomes and bulbs – turmeric







One Standard Adopted at Step 5

Forward to CAC47 for adoption at step 5 draft standard for spices derived from dried or dehydrated fruits and berries – vanilla



Would be subject to one more round of scrutiny (step 6/7).

Establish an EWG, chaired by the United States for America and co-chaired by Madagascar, Mexico and India, to consider the unresolved issues, taking into account the comments submitted at Step 6 as well as discussions in CCSCH7.

The unresolved issues : the alternate term for vanilla-caviar; provisions for food additives; labelling requirements for country of harvest; and which option to be used for the table on chemical characteristics.

Possibility of organizing a virtual working group meeting prior to CCSCH8 to facilitate extensive communication on the outstanding issues in view of the complexity of this topic.





New Work (Step 2/3)


To start new work on four different spices or culinary herbs and submit these new work proposals for approval by CAC47.



Sweet marjoram (proposed by Egypt) Draft standard: EWG (Egypt)



Cinnamon (proposed by Brazil) Draft standard: EWG Brazil, Indonesia, Iran and Mexico



The committee will work on draft standards for these four spices in its forthcoming sessions. Large cardamom (proposed by Bhutan and Nepal),

Draft standard: EWG (Bhutan, Nepal and India)

Coriander (proposed by India) Draft standard: EWG (India and Iran)










UPDATE TO THE TEMPLATE FOR THE SPICES AND CULINARY HERBS (SCH) STANDARDS

CCSCH7 agreed to:



Encourage active participation of Members and Observers in all discussions of the template for SCH standards and urged timely provision of comments. Publish the updated template prepared by the United States for America as a CRD (CRD32) and deferred its consideration to CCSCH8.




