



**Report of the 44th Meeting of Arab Countries Codex Contact Points - Chaired by the CCNE Coordinator**

As part of the launch of the new Codex season, the inaugural meeting to review the work plan of the Arab Food Codex Initiative for the period from February to June 2026 was held virtually on Monday, 26 January 2026. Dr. Intisar Al-Gharibi, Regional Coordinator for the Near East, opened the inaugural meeting of the Food Codex season for 2026 with a welcoming address to the participants. She outlined the objective of the meeting, which was to review the work plan of the Arab Food Codex Initiative for the period from February to June 2026. She noted that the new work plan is based on enhancing coordination among member countries.

Dr. Al-Gharibi emphasized that achieving the desired success can only be realized through joint work, proper planning, and continuous follow-up. She highlighted that this meeting represents an important milestone to review achievements, identify challenges, and set clear, achievable objectives aligned with the aspirations for the upcoming period.

She further explained that the goals for this year focus on improving performance quality and achieving a positive impact, drawing on the expertise of the participants. She concluded her remarks by expressing her gratitude to all attendees for their presence and constructive engagement.

Following this, Eng. Ahmed Al-Bashah, Head of the Standards Department at the Gulf Cooperation Council Standardization Organization, delivered an opening speech, welcoming the participants and stressing the importance of strengthening coordination and collaboration among member countries within the framework of Food Codex activities.

He expressed his appreciation for the efforts exerted in the context of the Near East Regional Coordination Committee and the Arab Food Codex Initiative, commending the active role and continuous support of the members for these meetings and the tasks entrusted to the Food Codex.

Eng. Al-Bashah also expressed his hope that this year would mark a strong start for activating Food Codex activities, contributing to highlighting the region's role in standardization projects developed by international Codex technical committees, both at the committee level and during the annual Codex Commission session.

He further stated that the GCC Standardization Organization has included, in its strategic plan for 2026–2030, a strategic project to support member countries and enhance their participation in Codex committee work at both regional and international levels.

He concluded his speech by renewing his thanks and appreciation to all participants for their attendance and active contributions.

### **Presentation of the Arab Codex Initiative Action Plan proposal (February–June 2026)**

Dr. Amine Kassouf, Scientific Director at the Global Organization for Food Regulatory Sciences (GForSS), presented the work plan of the Arab Food Codex Initiative for the period from February to June 2026. The plan was prepared in coordination with the Secretariat of the Codex Committee for the Near East Region and the Secretariat of the Arab Food Codex Initiative at the Arab Organization for Industrial Development and Mining Standards. This presentation was part of the follow-up on the implementation of the approved regional work plan of the Near East Regional Coordination Committee for 2026–2027.

The presentation addressed the overall framework of the plan and its objectives, particularly supporting the implementation of priority goals outlined in the Food Codex Strategic Plan 2026–2031, and enhancing the coordinated and effective participation of regional countries in Codex activities.

Dr. Kassouf also reviewed the main tasks of the work plan, as follows:

- Clarify the overall framework of the plan and its objectives, particularly supporting the implementation of priority goals in the Food Codex Strategic Plan 2026–2031 and enhancing the coordinated and effective participation of regional countries in Codex activities.
- Review the main tasks of the plan, which include following up on Codex activities, preparing for priority technical committee meetings, supporting the coordination of regional positions, and implementing capacity-building activities.
- Present a methodological framework for setting priorities for Codex committees and their agenda items, based on clear criteria including public health and food safety importance, regional impact, feasibility, and capacity-building considerations.
- Review the technical committees targeted during the first half of 2026 and the reasons for their prioritization, emphasizing the importance of systematic technical follow-up on their agenda items.
- Clarify the plan's implementation mechanism, including the formation of specialized working groups for each committee, coordination and follow-up procedures, and the role of supervisory bodies overseeing these groups.
- Present the proposed timeline for coordination meetings and relevant technical meetings during the period from February to June 2026.

- Highlight the proposed capacity-building activities, including e-learning courses and specialized workshops, aimed at enhancing member countries' readiness and supporting their effective participation in Codex work.

Dr. Kassouf noted that the plan serves as a practical tool to support systematic planning, enhance regional coordination, and ensure that regional activities are aligned with approved priorities, thereby strengthening the role of Arab countries and Near East region countries within the Food Codex framework.

He also presented two annexes, which form an integral part of the plan. Annex 1 provides a detailed methodology for evaluating and setting priorities for Codex committees and their agenda items, while Annex 2 presents a matrix aligning the proposed work plan with the Near East Regional Coordination Committee (CCNE) regional plan for 2026–2027. This alignment highlights the consistency of the proposed activities with approved regional priorities and supports systematic planning and follow-up.

**The following recommendations were adopted:**

- ❖ The possibility of including any additional committees that the region or member countries consider important for participation, based on regional priorities and needs. This includes the Codex Committee on Fresh Fruits and Vegetables (CCFFV), proposed by Eng. Al-Basha as part of next season's Food Codex activities, and the Codex Committee on Fish and Fish Products (CCFFP), proposed by the Kingdom of Morocco.
- ❖ Members emphasized the importance of holding regional coordination meetings well in advance of committee sessions, as this plays a key role in strengthening coordination among member countries, unifying regional positions, and supporting effective and coordinated participation in Codex committee work.
- ❖ The necessity to update the national contact points' information on the Codex website, ensuring accuracy and smooth communication, thereby enhancing effective coordination and information exchange between the Secretariat and member countries.
- ❖ All participants agreed to support the new plan and strengthen coordination among member countries in the Near East region (CCNE) regarding topics to be presented and discussed at the regional level, contributing to unified regional positions and enhancing the effectiveness of participation in Codex activities.

**Exploring optimal modalities for the Near East region's interregional coordination and engagement in colloquia**

**During the meeting proceedings**, Dr. Intisar Al-Gharibi, Regional Coordinator for the Near East (CCNE), presented the topic "Optimal Approach for the Near East Region's Participation in Inter-Regional Seminars and Coordination Between Regions."

She explained that the Near East Region (CCNE) has consistently participated in inter-regional seminars organized by several regional and international bodies, including the Arab Organization for Industrial Development and Mining Standards (AIDSMO), the African Union's Inter-African Bureau for Animal Resources (AU-IBAR), the Inter-American Institute for Cooperation on Agriculture (IICA), and the United States Department of Agriculture (USDA).

Recognizing the importance of enhancing coordination with other regions, and given the need to align the level of participation with the region's capacities and priorities, a proposal was presented aimed at supporting more organized, prepared, and effective participation in inter-regional seminars and related discussions.

### **Proposed Option:**

- ❖ Hold bilateral **colloquiums** between the Near East Region and other regions, based on the strategic considerations of each relevant committee and its level of priority for the region. Participation in inter-regional **colloquiums** should be limited to priority committees agreed upon at the regional level, allowing for more effective coordination, enhancing consistency in technical positions, and guiding the efficient use of resources.

### **Recommendation Adopted:**

- ❖ The meeting recommended adopting the proposed approach for the Near East Region's participation in inter-regional **colloquiums**, to enhance the effectiveness of regional participation, achieve better coordination with other regions, ensure alignment of such participation with the region's priorities and capacities, and support its influential presence within the Food Codex framework. The region will continue to circulate invitations to meetings organized by relevant regional and international bodies.
