

Addendum to the Action Plan of the Arab Codex Initiative – Implementation Priorities for September–December 2026

1. Purpose and Scope of the Addendum

This Addendum complements the Action Plan of the Arab Codex Initiative and defines the priority activities to be implemented during the September–December 2026 period in preparation for the 50th Session of the Codex Alimentarius Commission (CAC50). It should be read in conjunction with the [Action Plan](#), which remains the principal reference framework guiding the implementation of the Initiative.

Building on the progress and lessons from the previous implementation cycle (see [Arab Codex Initiative Progress Report](#)), this Addendum identifies the priority Codex committees and related activities to be supported during the September–December 2026 period, while highlighting areas requiring strengthened attention, particularly priority Codex committees, targeted capacity building, regional coordination, and follow-up of priority Electronic Working Groups (EWGs) and ongoing Codex work.

2. Priorities for the September–December 2026 Implementation Cycle

During the September–December 2026 implementation cycle, the Arab Codex Initiative will support regional engagement across six priority Codex committees (**Table 1**). All six committees are considered relevant to the Region and will therefore be covered through the Initiative, with the nature and level of support adapted to their respective agendas, identified regional priorities, and opportunities for coordinated regional engagement.

In line with the priority-setting approach established in the [Action Plan \(Annex I\)](#), the agendas of these committees will be reviewed in consultation with National Codex Contact Points to identify specific items requiring focused technical analysis, coordination, and support. This

process will guide the preparation of regional activities and positions, as appropriate, throughout the implementation period.

3. Strengthened Capacity-Building Component

During the previous implementation period, the organization of the 5th Arab Codex and Food Regulatory Forum could not proceed as planned due to the geopolitical situation in the Region. Subject to confirmation and prevailing circumstances, the Initiative will aim to organize the Forum during the September–December 2026 period.

Additional capacity-building activities will also be pursued, subject to identified needs, prevailing conditions, and available resources. These may include targeted initiatives on food risk analysis, data collection and management, and laboratory capacity building and training, with specific activities and modalities to be announced as appropriate.

4. Follow-up of Regional and International EWGs

The Initiative will continue to closely follow and support the work of priority Electronic Working Groups (EWGs) of particular relevance to the Region. During the September–December 2026 implementation period, particular attention will be given to the following ongoing EWGs and associated activities (**Table 2**).

5. Other Cross-Cutting Activities

During the implementation period, the Initiative will aim to support the Regional Coordinator and CCNE Secretariat, in consultation with relevant regional partners and stakeholders, in initiating preparations for the 13th Session of the FAO/WHO Coordinating Committee for the Near East (CCNE13), to be held in Muscat, Oman, from 5 to 9 December 2027. This will include supporting the early identification and development of potential new work proposals for consideration at CCNE13 that reflect the priorities, needs, and perspectives of the Near East Region, while facilitating early technical consultation and coordination among interested countries and stakeholders.

6. Reporting

At the conclusion of the September–December 2026 implementation period, a second progress report will be prepared and shared with the EWG on the “Implementation of the CCNE Regional Work Plan”, documenting the activities undertaken, key outputs and progress achieved during the cycle.
